## 2. Terms of References:

- The committee shall follow the procedure as mentioned in the UGC Notification, published in the Gazette
  of India (CG-DL-E-11042023-245095), named "University Grants Commission (Redressal of
  Grievances of Students) Regulations 2023", dated April 11, 2023, and time to update as per UGC
  notification.
- A complaint from an aggrieved student relating to the institution shall be addressed to the Chairperson, SSU Students' Grievance Redressal Committee (SSU-SGRC).
- The term of the chairperson and members shall be for a period of two years.
- The term of the special invitee shall be one year.
- The quorum for the meeting including the Chairperson, but excluding the special invitee, shall be three.
- In considering the grievances before it, the SSU-SGRC shall follow principles of natural justice.
- The SGRC shall send its report with recommendations, if any, to the competent authority of the SSU
  concerned and a copy thereof to the aggrieved student, preferably within a period of 15 working days from
  the date of receipt of the complaint.
- Any student aggrieved by the decision of the Students' Grievance Redressal Committee may prefer an appeal to the Ombudsperson, within a period of fifteen days from the date of receipt of such decision.
