Sub: Commission Order on the application submitted online by the Higher Educational Institution (HEI) for recognition of the programmes to be offered in Open and Distance Learning (ODL) mode from academic year 2026-27, academic session beginning August, 2026 and onwards-regarding.

Sir/Madam,

- UGC has notified the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments. Regulations 3, 4 and 5 describe the eligibility criterion for HEI, the process of application and the approval process for ODL and Online Programmes whereas Regulation 6 describes provisions of the right to appeal by the HEIs aggrieved with the order of the Commission.
- The Commission invited online applications from the eligible HEIs for recognition of the programmes under ODL mode and/or Online mode from academic year 2026-27, academic session beginning August, 2026 vide Public Notice F. No. 1-4/2026 (DEB-NWR) dated 23rd April, 2026.
- Application received from **Sri Sri University, Odisha** for recognition of **ODL** programmes was assessed by the Interface Expert Committee (IEC) duly constituted by the Chairman, UGC. The detail of the meeting is as under:

(ii) **Open and Distance Learning Programmes Not Recognized: NIL**

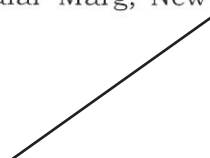
